The health, safety, and well-being of JUMPP students, staff, and families is always of the utmost concern in our operations and is a driving force for establishing health and safety policies and procedures. As we face this unprecedented public health emergency of COVID-19 Coronavirus, JUMPP will require that all staff and families abide by these newly established policies and procedures. These policies and procedures are set up as a means of supporting and protecting our children, families, and staff. Because the COVID-19 pandemic is a fluid situation, JUMPP recognizes that these policies and procedures are subject to change as they may need to be revised in response to changing trends and/or knowledge about the virus. Any changes will be communicated to families and staff.

### **General COVID-19 Information**

- COVID-19 or CORONAVIRUS is an infectious disease that is spread through the air by persons coughing or sneezing, through close personal contact, and/or by touching your eyes, nose, or mouth before washing your hands. This virus can result in a mild to severe reaction and can cause the following symptoms:
  - Fever (100.4 or higher)
  - Cough
  - Shortness of Breath
  - Difficulty Breathing
  - Respiratory Symptoms
  - Any 2 of the following: Chills, Repeated Shaking with Chills, Muscle Pain, Headache, Sore Throat

Research shows that children are likely to have milder symptoms than adults, but this is not always the case.

➤ **People who may be at higher risk of severe illness from COVID-19 include:**

- People aged 65 and over
- People of all ages with underlying medical conditions
- Any person who is immunocompromised
- People with severe obesity
- People with diabetes, chronic kidney disease undergoing dialysis, liver disease
- People who are pregnant

➤ **Tips for Parents:**

- Practice and reinforce good hygiene habits with your family.
- Wash your hands often for 20 seconds (sing Happy Birthday) with warm, soapy water, but especially after going to the bathroom, before and after eating, and after blowing your nose, sneezing, or coughing. Use Hand Sanitizer with 60% alcohol as a substitute for soap and water when needed.
- Keep your child home if they are sick with any illness. Contact your doctor to discuss your child's symptoms.
- Communicate any absences to the JUMPP office and/or your child's teacher.
- Be prepared with a backup plan for childcare in the event that our school must close your child's classroom or the entire preschool due to positive COVID-19 exposure. Talk to your employer or make alternate childcare arrangements ahead of time.
- Stay informed. This health emergency situation is one that changes rapidly. Stay up to-date with these resources:

- Take care of yourself! Spend a few moments each day engaged in self-care. Talk a walk, read, pray, listen to music, sit outside, yoga- whatever you enjoy, do it. Spend at least 10-20 minutes taking care of yourself and your mental health so that you can continue to care for your children and family in a positive way each day.

**COVID-19 Policies and Procedures**

➤ **Prevention of the virus from ENTERING the building:**

JUMPP will take all necessary precautions to keep the COVID-19 Virus from entering the school. These steps include:

- Everyone entering the facility will have a non-contact temperature check and will not be admitted if they have a temperature of 100 degrees or above. Masks and social distancing required.
- Only allowing staff and children in the building who are required/authorized for daily operations.
- Restricting Visitors- Visitors, including parents, and other church staff members will not be allowed in the school unless previously authorized by JUMPP Administration and/or the Senior Pastor.
- Daily health screenings will be conducted for all staff and preschool children including temperature checks on arrival. Staff members conducting the daily health screenings will be required to wear a face mask or Face Shield, maintain a six-foot distance while asking the following screening questions:

1.” Do you or do any of the children you are dropping off have a fever, cough, shortness of breath, difficulty breathing, other respiratory symptoms, or at least two of the following symptoms: chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell?”

2. “Have you or any of the children you are dropping off: Had any of these symptoms since last time you were last here?”

“Been in contact with anyone with these symptoms since the last time you were here?”

“Potentially been exposed to COVID-19 or have reason to believe you/they have COVID-19? “

Anyone exhibiting COVID-19 symptoms will be excluded for the period outlined in the School-Wide Response to Positive COVID-19 Exposure section.

➤ **Prevention of the spread of the virus WITHIN the facility:**

- Class sizes will be limited to 10 students, and we will maintain all child to staff ratios.
- Classrooms will include the same children every day. Staff will be kept consistent from classroom to classroom, with the only exception being in the event of staff absence and the need for a substitute.
- Playground times and enrichment classes such as music and Chapel will be staggered.
- Children will bring all food items from home and will not be shared with other children. All snacks and meals must be brown bag and be completely disposable.
- All drinking fountains will be shut off and covered. Igloo coolers and disposable cups will be used in the classroom. Parents will be required to furnish the cups.
- Cubbies will be issued to maintain social distancing. Children will be spread out as much as possible within their classrooms.
- Water play and sensory play with items such as rice, beans, playdough, and sand will be limited as much as possible. When sensory play does occur, items used will be disinfected in between children.
- Children will be reminded not to touch their eyes, nose, and mouth.
- Proper Hand Washing and Hygiene practices will be used for children and staff throughout the day. Children and staff should wash their hands for a period of 20 seconds with warm water and soap:
  - Upon arrival in the classroom in the morning
  - Before and after eating snacks
  - After blowing their nose, coughing, or sneezing, or in contact with bodily fluids
  - After toileting or changing diapers
  - After entry to the classroom from playground or other locations

- Hand sanitizer with 60% alcohol may be used in lieu of handwashing when needed.
- Staff members are always required to wear masks/face shields during drop off and pick up. Preschool children are not required to wear masks. No one under the age of 3 may wear a mask.
- Teachers and staff will use clear face shields.
- Students 4 years old and older will be issued a child's face shield of their own to be kept in the cubby and cleaned at the end of the day. Younger children will not require masks or shields.

➤ **Sanitation Practices:**

JUMPP will continue to follow best practices for hygiene, cleaning, sanitizing, and disinfecting the classrooms and materials used. Routine cleaning of all surfaces and items frequently used will occur throughout the school day. Toys will be sanitized throughout the day as needed, and at the end of each school day. Classrooms and bathrooms will be cleaned and disinfected at the start, during, and end of each school day as well. JUMPP will refrain from using washable cloth toys during the COVID-19 pandemic. Linen items such as rags and towels will be washed daily.

➤ **Arrival and Departure Procedures:**

**Arrival (8:10-8:30)**

- We apologize for the inconvenience, but to keep everyone safe, parents/caregivers will not be able to walk children to class.
- In the car line, the parent is responsible for taking the child out of the car and going to the check-in station. Be sure to have child's backpack, lunch, coats etc. Masks and social distancing required.
- The check-in station will take a non-contact temperature check and ask if anyone in the home has tested positive.
- A teacher will walk the children to the entrance where they will walk on a sanitizing mat and use hand sanitizer before going to class.

- Students arriving after 8:40 will park and take the child to the entrance. The same procedure above will take place at the entrance.
- Parents of Mom's day out and PK2 will park as usual and walk to the entrance where the above procedure will take place.

**Departure (12:15-12:30)**

- Parents will park and go to the entrance.
- Masks and social distancing required
- Children will use hand sanitizer before being delivered to the parent.

If you arrive earlier than your schedule time, please wait in your car. If you arrive late, please wait until after 9:00 a.m. to bring your child into the school. Please be on time for pick up as we will not be able to allow your child to leave their classroom until you are there. We know this is going to be a very different situation for our children. We know that some will be hesitant about being left and will become upset when you leave them. We promise to make the drop off as easy as possible. We are asking that you begin to have the conversation with your child now to know that you will not be able to walk them to class and there will be no community play time in the mornings. Each teacher will be in their classrooms waiting to greet the children and welcome them at the beginning of each day. There will be fun activities for them in the classroom before the instructional day begins.

➤ **Children or Staff Who Develop Symptoms During the Day:**

Any child or staff member who develops symptoms during the school day, will be sent home as soon as possible. In the case of a child, JUMPP will follow our Sickness Policy as outline in the Parent Handbook.



➤ **School-Wide response to COVID-19 exposure:**

In the event that an enrolled child or staff member tests positive for COVID-19, JUMPP will take the following steps. All efforts to maintain confidentiality will be made.

- JUMPP Staff members will be expected to follow this policy for returning to work as outlined below:
  - If a staff member tests positive for COVID-19, they must quarantine at home for a period of 10 days, and the Georgia Department of Health will be notified. JUMPP will follow their guidance and recommendations for any necessary classroom and/or school closings. Parents of children in that classroom will be notified that there was a positive COVID-19 case. A deep cleaning of the classroom will occur. The staff member must be symptom free and have a negative COVID-19 test result before returning to work.
  - If a staff member has had contact with a person who is COVID-19 positive, they must self-isolate at home for 14 days. They will be required to have a negative COVID-19 test result before returning to work.
- **Enrolled Child:**
  - If a child tests positive for COVID-19, that child must quarantine at home for 10 days, and the Georgia Department of Health will be notified. JUMPP will follow their guidance and recommendations for any necessary classroom and/or school closings. Parents of children in that classroom will be notified that there was a positive COVID-19 case. A deep cleaning of the classroom will occur. The child who tested positive **MUST** have a negative COVID-19 test result and be symptom free before returning to school.
  - If a child is exhibiting symptoms and has been exposed to someone who is positive for COVID-19, they will be required to present a negative COVID-19 test and medical clearance from their doctor to return to school. A deep cleaning of the classroom will take place.



- If a child is exhibiting symptoms, but has no known exposure risk, they will be required to remain at home until they are symptom free for a period of 72 hours without the aid of medication. The classroom will remain open.

## **Exposure**

If a member of staff or student has been exposed to someone who is positive, they will be required to be in quarantine for 10 calendar days and have a negative Covid test prior to returning to school.

We will continue to keep you all updated if there are any changes.

We appreciate your support and confidence in us to keep your child and family as safe as we know how using all the guidelines and directions from the local, state, and federal child agencies.
